115. Chairman's welcome

The Chairman welcomed everyone to the meeting and thanked Councillor Avril Jones for Chairing the January meeting in his absence.

118. To confirm the minutes of the January 2018 meeting

It was noted that a letter had been received from Gwynedd Council regarding the expansion of the 30mph speed on the road out of Llanrug towards Pontrug.

- c) Complaint It was reported that a complaint had been received about the condition of the cemetery one morning. The nature of the complaint was that flower pots had been scattered throughout the place. It seems that following investigations the recent strong winds would have caused this.
- d) Price for the wall It was noted that prices had not yet been received due to the proposed contractors not able to submit a price at present because the work will not start until the Summer.
- e) Risk Assessment It was reported that there was no risk assessment of the cemetery and one was required to be carried out.

Report to the Community Council - February 2018

Council Tax 2018 / 2019

The Cabinet has now made a decision and asks Full Council at its meeting on March 1st to approve a 4.8% increase in taxes next year.

Although the Welsh Government had received a 2.6% increase in its grant from the British Government, they only gave 0.2% to the Local Government, they have decided to give more money to Health. Gwynedd has done better than some other authorities has had a 0.6% increase, however, of course, inflation is 3.1% at the moment, so not enough increase in the grant to respond to inflation.

Planning

The Plas Tirion chicken scheme will go ahead of the Planning Committee in Dolgellau on the 26th of February for a decision.

Locally

Upgrade of the footpath between Cwm y Glo and Llanrug, due to start on 19 February and take around six weeks. Arrangements will be in place to ensure that a temporary footpath is in place while work is completed. This will mean reducing the speed limit of 50 mph to 30 mph temporarily.

I have also received confirmation that the road through Cwm y Glo will be resumed in the next financial year and also the pavements will be made.

Work is still underway to try to prevent people from discharging waste close to the recycling bins at Cwm y Glo. One or two people recently caught. The authority is keen to receive any information about any business with cats in the area, because there are many bin bags with a cat litter in which they are often dropped. If you are aware of anyone if you can let the Authority know, or let me know.

- Discuss if it is necessary to add the Llanrug school and / or the CYG School attached to the event.

Appoint a member of the LL and CYG council to write a piece to advertise the event on Eco yr Wyddfa.
