# 497. To receive a presentation from Mrs Rhian Whiteside-Thomas on behalf of Llanrug Primary School

A presentation was received from Mrs Rhian Whiteside - Thomas on behalf of Llanrug Primary School. She explained that the school would welcome the support of the community council as the school is currently in the process of applying for grants etc. She explained that children are expected to go out to play these days, and this is going to become statutory in schools, but when the weather is bad, this is not currently possible in Llanrug. The school tries to apply for grants and one of the conditions on many applications is that the community supports it.

# 498. To receive a report from Councillor Cemlyn Jones on the meeting of the governors of Llanrug Primary School

Following the above presentation, no further report was available. It was requested that the item be placed on the November agenda.

### 499. To consider whether Llanrug Community Council aspires to be a Council with the general power of competence.

The Chairman reported that he had recently attended a meeting of One Voice Wales in Pwllheli with the clerk and one of the implications that was to come soon was the need for Community and Town Councils to be awarded the GENERAL Power of Competence.

In 2018 an independent review panel made 47 suggestions for changes to the way community and town councils work in Wales.

The Minister has now recognized out of the 47 suggestions that 3 of them will be moving forward for legislation soon.

Currently, because of 'BREXIT' the process is slower than expected moving through the Assembly.

It was originally promised in June, but this has now moved to October.

These 3 suggestions are not shocking news, because it confirms the current First Minister's intentions and aspirations for the future role of community and town Councils.

#### 2. The three suggestions

- 1. Mandatory Annual Report for all councils;
- 2. Competence powers;
- 3. Mandatory training for all councillors

### **Mandatory Annual Report for all councils**

This is a way to engage with the community and inform residents of what the council is doing for them. Members will recall that this council passed that we would produce a pamphlet for distribution to the residents of Llanrug and Cwm y Glo before the end of March 2020.

#### **Competence Powers**

If the council wishes to be identified as having the power of general competence, the following must also be met;

- a) Two thirds of the members must have been elected. Llanrug meets this because 12 members have been elected (no election is required) and two have been coopted;
- b) It is essential that the clerk is suitably qualified, e.g. CiLCA. Llanrug meets this criterion:

#### Mandatory training for all councillors

Make it compulsory for all councillors to attend in-service training. Training is likely to be (but not limited to), the Code of Conduct, The Council as a body, working with other councils that include Gwynedd Council or neighbouring community councils.

What is it for?

If the council succeeds in gaining the inclusive power then it will allow the council to do anything an individual can do unless specifically restricted by the general power or other legislation. For expenditure under the above, the Welsh Government sets an amount for each financial year where it can be spent under s137 and for 2019/2020 is £ 8.12 for each elector.

This would mean that this council can spend up to £16,865.24 (£ 8.12 x 2077) under this section. Of course, it does not mean that the council has to spend it just that it has that power if it wants to and it will strengthen the status of Llanrug Community Council.

# 500. To receive a report from Councillor Berwyn Parry Jones on activities during the month at Gwynedd Council.

#### **Buses**

There has been a recent consultation on the use of buses, asking what loss of bus would mean to residents. The idea is to try to organize the service better, so that the buses run to suit wherever possible. Possibly make use of smaller buses and taxis, but at the same cost to the users.

#### **Planning**

As new houses are built, others are sold as holiday homes or Air B&B. The council has commissioned an expert to see if this sale can be managed, either through the Planning or Licensing system. They are going to look at the kind of arrangement that is in place in other countries, such as Ireland being one.

#### **Cwm y Glo School Building**

The County Council will be writing to the last members of the Hall Committee to outline their intention to create a new lease with Menter Fachwen. If there is no objection, they will contact the Community Council to ensure that they are willing to surrender the existing lease, and then proceed to discuss and create a new lease with Menter Fachwen. The lease will include a clause stating that community use of the building must also be allowed.

### 'Bund' by the playing field at Cwm

Proud to say that the construction of the bund has finally taken place, this should avoid flooding the rear of Pool Street houses.

#### **Dolafon Scheme**

Still waiting for the work at Dolafon to be done. The Council and Adra Housing Association have agreed a plan that will be jointly funded, but to make the scheme a Scottish Power pole has to be removed, they want a high price to move it, wait for an update now

#### Multi use route from Llanrug to Pontrug

I've been asking for this for a while now, it seems that it will be done as part of the Bontnewydd bypass scheme. The county council is keen to have a multi-use route running from Llanberis to Caernarfon.

# 501. To receive a report from Councillor Charles Jones on the month's activities at Gwynedd Council

#### Hafan Elan - Official Opening of the refurbished Hall

It was a privilege to cut the ribbon on the official opening of the newly refurbished social centre on 10 October. Almost 40 years have passed since the estate opened in 1980, and 45 years since I asked Arfon Borough Council to provide suitable housing for the elderly on this convenient site near the village square. It is also pleasing to note that 'Adra' (the new name of Gwynedd Community Homes) has agreed to add 12 parking spaces on the estate.

### **Ogwen Public Footpath**

Gwynedd Council has repaired the wall that holds the path up near Ogwen. The stone wall and base of the path had fallen into the river at one location. So, again, the path is safe for pedestrians.

# 503. Issue regarding the wall between the old post office and Ysgol Brynrefail (Cllr Haf Williams)

Councillor Haf Williams reported that she had received several complaints regarding the condition of some of the walls which are overgrown and affecting the vision of traffic. It was noted that cars were being scratched with overgrowth. Pictures she had taken were shown where he outlined the problem as well as other locations in Llanrug.

It was further noted that the condition of the wall, from the direction of the square towards Ysgol Brynrefail was poor and that it was in breach. This has already been brought to the attention of Gwynedd Council.
