#### 381. To receive a welcome from the Chair

### 384. To confirm and accept the minutes of the meeting held March 2019

The minutes were accepted and signed by the Chair.

#### 385. To discuss any matters arising out of the minutes.

Councillor Hefin Jones raised the question of what is the meaning 'parish' in respect of what was said by the Reverend Robert Townsend on his visit to the March meeting.

It was noted that the Reverend Townsend had agreed to attend the May meeting and this would be an opportunity to seek clarification.

# 387. To receive a report from the council's representative on the governing body of Cwm y Glo school.

It was reported by Councillor Alan Pritchard, that Menter Fachwen have shown an interest and have developed plans for the school but it was a requested the community Council should confirm to Gwynedd Council they do not have any plans for the school and to confirm their support for the application.

**Resolved:** As members had not had an opportunity to discuss the request and the need for a decision to be conveyed to Gwynedd Council as soon as possible, it was resolved that a special meeting of the Council be convened at 19:00 on Tuesday 29th April 2019, at the Institute, Llanrug. In the meantime, Councillor Alan Pritchard would send outline of the plans to the Clerk in order they are circulated in preparation for the meeting.

# 388. To receive a report from Councillor Berwyn Parry Jones on last month's activities in Gwynedd Council.

#### **Language Centres**

Following the decision of the Full Council to ask the cabinet to reconsider the reorganisation of the Language Centres, the cabinet decided to defer any decision for a year. In the meantime, it was also decided to trial a service with one teacher in one of the centres to see if there would be any negative impact on the standards.

#### **Planning Training**

I attended training on planning which discussed the role of community councils in the planning process. It was pleasing to see that there was representation from Llanrug and Cwm y Glo Community Council in the training. The number of other community councils present was disappointing. Only three!

#### Locally

#### Cwm y Glo School

By now, the official statutory decision has been made to close the school. This will take place on 31 August 2019. As a comment on closing the school, I have stated to the Authority that it will be important for whoever takes the building over to ensure that there will be an opportunity for community use.

#### Multi use footpath Cwm y Glo to Lanrug

I am in discussions with council officers to try to improve safety along the path. The crossing opposite Dôlafon needs attention. Hope to have a solution soon.

It was reported that as part of the community engagement and to inform residents of the work being undertaken by the community council a database be created where anything related to the council could be emailed. This could also mean any events that are being organised by the council could be advertised.
